Organizations including but not limited to public, private, tribal, or non-profit entities, including school districts, under contract with DCYF or subcontract with a CLA to provide early intervention services in an assigned geographic and/or school district catchment area.

Geographic school district boundaries as defined by the Office of Superintendent of Public Instruction.
